



## Inter Pipeline Announces May 2018 Cash Dividend

CALGARY, May 7, 2018 /CNW/ - Inter Pipeline Ltd. ("Inter Pipeline") (TSX:IPL) announced today the declaration of a cash dividend of \$0.14 per share for May 2018. This dividend will be paid on or about June 15, 2018 to shareholders of record on May 23, 2018. This dividend is designated as an "eligible dividend" for Canadian tax purposes.

Since inception, Inter Pipeline has distributed approximately \$4.6 billion in cash payments to investors. Inter Pipeline's objective is to provide investors with sustainable monthly cash dividends, with dividend growth upside tied to the development of Inter Pipeline's portfolio of growth projects.

**Inter Pipeline Ltd.** Inter Pipeline is a major petroleum transportation, natural gas liquids processing, and bulk liquid storage business based in Calgary, Alberta, Canada. Inter Pipeline owns and operates energy infrastructure assets in western Canada and Europe.
